3012 POLLUTION PROHIBITION

This bill prohibits munincipalities from placing polluting substances on roads, streets, and other areas within a munincipality, or dumping into water that empties into navigatable water, or where by seepage navigatable waters may be adversely affected. Violation will make the munincipality ineligable for grants loans from the Pollution Control Fund. (passed & signed)

Under this bill Portland has till 1975 to correct pollution problems or the City of Portland Dump (the only place which Washington County has to dump) will be effectively closed.

EDUCATION

131 TEACHERS FAIR DISMISSAL

This bill creates a Fair Dismissal Appeals Board and prescribes review procedures and criteria. Requires district superintendent of any common or union high school district to conduct annual evaluation of teachers and maintain personnel record of specified contents for each teacher.

Minority Report provided that these standards be extended to all districts, not just those with daily membership of more than 4,500 students.

> 1) Teachers in small districts as are located in Western Washington County, need protection too.

006 CAMPUS CLAIMS

Explanation:

This bill gives \$62,478 to pay for the damages that were the result of disturbances on Eugene and Portland campuses.

This bill directs that ballot statements on tax measures shall state the percentage increase, but not the actual dollar amount involved.

8 LEGISLATIVE COMPENSATION COMMITTEE

This bill creates a commission for the setting of legislative salaries. The members of this commission to be <u>citizens</u> appointed by the Speaker of the House.

This bill provides that persons over 62 years of age shall receive a Senior Citizens' Newsletter to inform them of their rights, benifits, and other priveleges that are available to them under state law because of their status as senior citizens. HB2032 VETERANS FUNDING

This bill cuts Spanish War Veterans Educational aid by \$11,000.

HB1891 FARM LABOR CAMPS

ALL JUST MENTIONED BILLS WERE TABLED

There were eight bills for which Hugh was the sole sponsor. of these eight bills, five of them were at the request of the Metropolitan Study Commission, two of them were at the request of the District Judges Association, and the remaining one was at the request of the Oregon Disrict Judges Association.

Public Safety Administration Account is created, with necessary amounts appropriated or otherwise available to agencies or functions in the Department of Public Safety, to be transferred to the account quarterly, with approval of the Executive Department, for payment of administrative expenses of the Depart-(DIED in adjournment in Senate) 1059 - Creates Department of Human Resources to coordinate and provide programs, through existing agencies, for public assistance, children and families, economic opportunity, aging, vocatioal rehiabilitation, corrections, mental health, and employment under director appointed by Governor. Requires that department be recipient of federal funds for providing its designated services. Authorizes Director , with approval of Governor and Emergency Board, to make transferrs of appropriations and expenditure limitations for programs within divisions in department.

1060 - This bill places responsibility for health and health related functions in the Department of Human Resources, and estabblishes a Health Affairs Division. The Board of Health, Comprehensive Health Planning Authority, Drug Advisory Council, Board of Social Protection and various licensing boards for health professions are placed in the department. - *1861 This bill enacts the Oregon Motorist Information Act of 1971. A travel Information Council consisting of 11 appointed members is created. It adopts regulations for motoreist information signs and directs the State Highway Commission to maintain tourist information offices. It sets permit requirements for motorist information signs and outdoor advertising signs and provides a fee schedule based upon sign area. The Commission is granted the power to purchase or excercise eminent domain to acquire interest in land or signs. Any sign in violation

of this Act is declared a public or private nuisance. The owner is liable for the cost of removal of an unlawful An outdoor advertising sign in existence on the effective date of this Act and lawfully located may remain. Specified signs lawfully located on the effective date may be removed with just compensation to the owner after July 11976, and in certain cases i.e., in scenic areas, prior to July 1, 1976, certain signs erected pursuant to "waivers" may be removed without compensation. It is declared to be the legislative policy to prohibit outdoor advertising signs except in zoned commercial and industrial areas. Regulations relating to the size, height, area and spacing of outdoor advertising signs are provided. A persons in the business of erecting or maintaining outdoor signs is required to obtain a license. Penalties of a \$100 maximum fine or a maximum of 30 days imprishment are provided upon conviction of a violation of this Act. It establishes a Tourist Information Council sub account of the State Highway Fund and authorizes an appropriation of \$5,000 from the Highway Fund to this sub account. (passed & signed)

SENATE BILLS WHICH HUGH CO-SPONSORED

68 - This bill increses the number of circuit judges for Lane
County from five to six, and for Clackamas County from
three to four, effective July 1, 1971; for Marion County
from four to five, effective January 1, 1973; and for
Multnomah County from 17 to 18, effective the first Monday
in January, 1973. The additional Multnomah County Circuit
Judge will sit in the department of domestic relations,
the fourth in that department.(passed and signed)

244 - This bill establishes the State Building Code Division in Department of Commerce. It directs the adoption of a state wide building code which would supercede local building codes. The director may modify application of the code to specified classes of buildings or areas of the state. Local governments may enact and enforce regulation matters not covered by the state codes. The duties of city and other local building officials under the state code are specified. Any stationary structure- constructed within a mobile home park after June 30, 1971, must be constructed within the state building code. The bill prohibits any person from renting, leasing or selling a recreational vehicle, house trailer, or mobile home unless it bears an insigne of compliance and meets the minimum safety standards prescribed by the Director of Commerce. transfers authority of the State Board of Health and the Commissooner of the Bureau of Labor to adopt regulations on building construction, equipment installation, and certain hazardous uses, to the Director of Commerce. (you voted against it. At desk upon adjournment)

277 - Requires rules and regulations adopted by Enviornmental
Quality Commission or regional air quality control authority to make provisions to permit any person, under resonable conditions and as prescribed by rule-making authority
and local fire department, to burn wood, leaves, shrubs,
and other vegetation growing on property used by applicant
as residence. Authrizes rule-making authority to prescribe
phase-out of such burning by January 1 1975. Allows voters
of city to remove city from provisions, except that if
burning is extended beyond January 1, 1975, rule making

authority must be continued. (tabled in House Enviornment)

411 - Establishes seven member Legislative Compensation Commission to recommend compensation and expense rates for legislators and compensation rates for legislative employees not employed by statutory committees. Requires recommended rates to be submitted for legislative approval. Excludes amounts received by legislators from tax definition of gross income. (committee upon adjournment - Rules & Resolutions)

AUCOIN LEGISLATIVE PROPOSALS

member Public Welfare Commission and county public welfare to advise Public Welfare Division. Transfers certain duties regarding foster care from Public Welfare to Children's Services Di-Abolishes county welfare commissions and state advisory committee on welfare. Requires local welfare office in each county. pirects commission to evaluate effectiveness of public welfare programs in relation to local needs and to develop locally sponsored programs to augment public welfare programs. Requires Public Welfare Divison to determine eligibility for all public assistance. (Signed) This bill requires all government buildings constructed after the effective date of the act to have at least one primary entrance accessible by appropriate ramp or other suitable entrance for handicapped persons. Buildings renovated after the effective date shall also be accesible to handicapped persons. The act would be administered and enforced by the state ${f F}$ ire Marshal, who is given power to waive the specific standards set forth in his regulations if he finds that a proposed alternative is in substantial compliance with or an acceptable alternative thereto. An advisory committee is established to be appointed by the governor, at least two members of the four public members of which must be handicapped persons who use wheelchairs. Other members would be an architect, the chairman of the Committee on Employment of the handicapped, the state architect, and the administrator of the Vocational Rehabilitation Division. (signed) This bill expands the present authority of the Game Commission over fish, game and bids, to include all "wildlife". The extension is to mammals not now classified as game or fur-bearing animals, and to amphibians and reptiles.

bill grants school districts specific authority to compensate plants employees in any form including (but not limited to) insurance and its reimbursement as well as salaries. Also requires a standard for reporting compensation .

the regularlyscheduled lunch hours for all full-time certified staff

public contracts in excess of \$50,000, leaving provision that bid security will not exceed 10% of bid, to apply. Authorizes public officer to determine, amount of bid security to be forfeited if bidder fails to enter into contract.

Reduces compulsory school attendance age from 18 to 16. Deletes provision exempting from full-time attendance students lawfully employed.

- provides for notification of persons over 62 years of age of rights, benifits or other priveleges available to senior citizens under state law.
- Increases percentages of senior citizens' homestead tax exemption.

 Requires containers of certain volume, which pesticides are sold or offerred for sale to have refundable deposit value of not less than 50¢ nor more than \$10. Requires containers to bear label or stamp indicating refundable deposit value.
- Permits taxpayer to make monthly instalment payments of property taxes.
- Freezes homestead value when taxpayer reaches 65 years of age, subject to possibility of reduction. Authorizes value of homestead aquired after age 65 to be frozen at value in year of acquisition.

Prohibits state financial aid to students enrolled in branch of institution of higher education in state but headquarters of which are out of state unless approved by Educational Coordinating Council.

- Requires license to manafacture drugs, including those that cannot lawfully be sold.

- Authorizes rent reimbursements up to \$150 monthly for legislators who maintain place of residence in Salem but reside permanently more than 20 miles outside Salem city limits.

- Requires that proof of financial responsibility be submitted to Motor Vehicles Division prior to operation of motor vehicle on highways (invehicles Division prior to operation of Requires revocation of stead of requiring proof after accident). Requires revocation of licenses of persons who fail to comply, and restoration upon proof of responsibility.

- Establishes a Juvenile Code Committee to prepare a revision of the laws relating juveniles, juvenile courts and child welfare.

- Establishes financial aid program for post-high school students based on difference between financial ability and cost. Prohibits grant to student difference of religious study.

Authorizes the State Scholarship Commission to contract with private suthorizes of higher education to provide secular education at rate institutions of for every 45 quarter hours completed by an undernot to exceed \$250 for every 45 quarter hours completed by an undernot student who is a resident of the state.

prohibits public bodies from purchasing supplies, equipment of services prohibits public bodies from purchasing supplies, equipment of services other than personal from manafacturers not in compliance with air and water pollution regulations. Requires commission to prepare list of manafacturers not in compliance and make list available to any person. In particular, disability benifits and beefits at death for law enforcement officers to be administered by Public Employes' RetirementBoard. Allows credit for military service.

prohibits munincipalities from placing polluting subs-ances on roads, streets and other areas within a munincipality, or dumping water that empties into navigable water, or where by seepage navigable waters may be adversely affected. Violation will make the munincipality ineligible for grants or loans from the Pollution Control Fund.

Authorizes state grants to employers to provide work opportunities to recipients of public assistance and persistantly unemployed persons.

Creates Jobs Board. Requires board, Public Welfare Division and Employment Division to formulate plan for determining employability of persons to fill work opportunities for which grants are made. Requires that persons employed to fill positions created by state agency program improvements in times of economic crisis be unemployed residents.

Enacts Oregon Enviormental Protection Act to require Enviornmental Quality Commission to review undertakings of public agencies or actions or activities of other persons that require public agency approval where such undertaking, action or activity has or may have substantial enviornmental impact

Revises statement of unfair and deceptive trade practices. Authorizes persons attorney general and district attorneys to bring suit against persons attorney such practices, and to make investigative demands. Establishes employing such practices of reasonable cause for knowledge as delack of knowledge and absence of reasonable cause for knowledge as defense. Authorizes and establishes procedures for class actions. Authorizes award of punitive damages. Authorizes court to appoint receiver for interests of persons employing such practices. Authorizes private right of artions by operson damaged by such practices; provides civil penalties.

Requires legislators to disclose conflicts of interest relating to matters under consideration prior to votes on such matters. Creates

 $_{\mbox{\scriptsize Increases}}$ maximum percent interest limitation for designated retail $_{\mbox{\scriptsize instalment}}$ sales and loans to 12% per annum.

Establishes office of Oregon Consumer Counsel to represent interests of individual consumers in proceedings conducted by state agencies.

Establishes the Oregon Recreatioal Trails System.

Requires that all freight cars be free of loose objects, and that tops be free of abrasive material that might blow off enroute, before being placed in trains for movement.
