SUBJECT: Report *4/1*

Ezra Koch called for two reasons: 1. A contingent of chiropractors visited him earlier this week asking him to put pressure on you to dismiss Crothers. Their indication was if Ezra could deliver, then the chiropractors would endorse you. I told Ezra unfortunately the chiropractors had already announced their decision two months ago on endorsement, but that you are aware of the problems with Crothers and actions are underway.

To further update you, Roy Green is gone and won't be back until Monday. Norma Paulus has called indicating she has heard you wish to remove Maurie Crothers. Several others have called indicating it would be a mistake on your part. A, he is in bad shape health-wise, and B, it would give the appearance that you have rolled over to a very narrow representation of the chiropractors and some chiropractors who in fact are creating bad names for the good chiropractors. We are checking all these statements, but wanted you to know.

The second thing Ezra called about is of a personal nature. The NAIA has come to Ezra asking that he get word to you that at the last NAIA meeting criticism was lodged regarding your behavior. Apparently this criticism started two years ago with your appearance at the Hayward awards. The NAIA coaches are concerned that when you appear before athletic groups you smoke incessantly. (Me too.) Coaches are fearful this creates a wrong image for the athletes and is counterproductive to the image the coaches are trying to create for those same athletes. Ted Wilson is the one who approached Ezra and asked that the message be delivered. Consider the message delivered, and you have my sympathy and understanding.

Update on timber contract bid issue. It was decided that the state timber sale bids would be postponed from the original scheduled date of November 4. Both Clay and Norma agreed with this action. A new issue has hit us and that is some of default companies are anxious for that bid so that they can project manpower needs. They are not concerned about postponement, but are wondering how soon the bids can be *made*. There is some discussion now to see if it is possible that a special land board meeting could occur next week to accommodate this decision. I have asked Pat to survey the other board members before making any decision. If you will recall, the issue here is whether or not the default companies had the right to bid and if they do, how can their bids be considered if they should be the winning bidder. What did complicate the issue is that Norma feels strongly the rules

should be applied retroactively and Clay feels that if no commitment was made to apply them retroactively, he would be willing to proceed from the date of the rule. Pat is trying to get the tapes to see if at any time the land board members made a commitment to retroactive application.

However, on 10/25 Bill Hoelscher was able to dissolve that restraining order. Ballots were mailed last Friday and the election has been formally sanctioned. We are trying to keep it removed from the Governor's office and all inquiries are being referred to Bill Hoelscher.
