Regardless of location, MM would have it sister operation in N.C. as a captive customer while close proximity to the Fujitsu operation in the Gresham area is viewed as being critical to maintaining the Fujitsu-MM relationship. With the delay in construction announced by Fujitsu, MM follows Fujitsu's lead by postponing their internal site selection process. It is known, however, that Oregon is a preferred site due, in part, to the great amount of information compiled by Mitsubishi Electronics during its site selection process wherein Salem was the #2 choice.

BACKGROUND: Recent policy decisions in the firm have dictated that 50% of the firm's sales should be made and sold in Japan; 25% of the sales should be exported from Japana; and 25% of

sales should be made and sold in overseas markets.

According to this policy, 50% of Matsushita's U.S. sales should be from products produced in the U.S. The current level is 15%. For 1985, total U.S. sales for the Matsushita group will amount to about \$4 billion. The firm now has 7,000 employees in the U.S., 500 in Canada and 500 in Puerto Rico.

Internally, the manufacturing divisions will make the concrete plans for what products can be manufactured overseas while the Electric Trading end of the firm is charged with implementing the investment. Last October, the group functions within the organization changed. Prior to that time, Electric Trading was primarily reponsible for the movement of goods both from within the firm and in connection with business with outside companies/3rd country business. In October, 1984, Electric Trading became primarily responsible for overseas production. At that time, Yasuda and Ishijima were transferred from Electric to Electric Trading to spearhead the changeover.

The firm has not reached a decision on what will be produced in the U.S. as of yet; they have production plans in hand from all the various divisions. In addition to VCRs and ICs, contacts indicated that many other products could and should be manufactured in the U.S. In the next five years, "more than several" factories will be established in the U.S.

BACKGROUND: Representative Nikaido is the leader of the largest faction of LDP and is a very likely contender for Prime Minister when PM Nakasone's term ends. It was Nikaido's wish that the Governors of the various states could somehow get together periodically to meet with leading/influential MPs in Japan and/or the U.S. in order to further understanding and defuse trade friction, etc. JRO has arranged this meeting with the thought that Governor Atiyeh is in a position to exchange opinions with Rep. Nikaido and if there appears to be promise/merit in taking the results of this discussion/proposals to WGA or NGA, it would enhance the position of Rep. Nikaido, reinforce Governor Atiyeh's image in Japan and provide a leadership platform within WGA and/or NGA.

Oki Denki or Oki Electric produces Information Processing Systems (50%); Telecommunication Systems (25%); and Electronic Devices (25%). The President's name is Namio Hashimoto. The Exec. V.P. is Mr. Kosugi and the Senior Managing Director and President of the Electronic Devices Group is Mr. Y. Masuda. The other Senior Managing DCirector is Mr. C. Mitsuyasu.

Oki has a total of 13,000 employees worldwide. Their reputation is for high quality. The company was founded in 1881 by Mr. Oki who built Japan's first telephones. The company has since diversified into areas such as fiber optics and semiconductors.

The company has adopted a medium range plan called the "1990 scenario" which calls for doubling sales which are currently \$1.7 billion. Oki has formed joint ventures with such companies as Intel and National Semiconductor.

Information Processing: The company is proud of its "microline" series of computer printers which were the first in the world to be produced by robots.

Telecommunications Systems: The company is proud of their sophisticated cellular mobile telephones.

Electronic Devices: Oki is aiming to totally automate its production facilities to provide a competitive edge in this highly competitive market.

Oki Denki has a U.S. subsidiary called Oki America which has three groups: Okidata which is headquartered in Hackensack, N.J. and produces computer printers; Oki Semiconductor which is headquartered in Sunnyvale, Californian; and Oki Telecom which produces mobile celluar telephones and is located near Atlanta in Norcross, Georgia.

OKIDATA: Economic Development is currently working with Okidata which is currently conducting a feasibility study for new printer facilities on the West Coast. Currently, Okidata is only assembling and packaging printers in the US. The Okidata project could include a new assembly location in Oregon; a new production and assembly; or, conceivably, a new corporate headquarters as well a production and assembly. OKI SEMICONDUCTOR: A contact was established with the president of this company following a telephone call by Governor Atiyeh based upon a tip by Casey Powell who is a personal friend of the President of Okisemiconductor, Jerry Crowley. This contact was made in early October, 1985 and in late October, Schulberg visited the semiconductor facility in Sunnyvale, California. At the meeting was Jerry Crowley, President; Mr. Tatsuo Ishihara, Exec. V.P.; Mr. Larry Chalfan, Sr. V.P.; and Mr. Ikuo Anada, General Manger of Design Technology, Electric Devices Group of Oki Electric, Japan. The first meeting went very well and everyone agreed that a Japan side meeting with the parent company would be good.

Therefore, we are talking about two potential investments that are currently under study: Okidata which would produce printers and Oki Semiconductor. Timeline on both projects is generally expected to be not lengthy. Despite tough times in the industry, both subsidiaries are doing well in the US.

BACKGROUND: Toshiba Electric is Japan's second largest general electric machinery manufacturer. The firm is #1 in the area of office automation equipment. Toshiba has had close historical ties with General Electric; noted for nuclear power plant technology and highh overall level of technology in a broad range of applications. Yen 103,000,000,000 (~\$412,000,000) is to be invested in new semiconductor plant construction in addition to the six plants started/announced in 1983. Corporate intention is to expand its share of electronics and communications items to 48% of sales by 1986. Company's semiconductor facility in Sunnyvale, California is described by company officials as being "less than adequate" to meet future requirements in addition to problems associated with the location. Firm is concerned with future "even-handed" treatment by state and local governments citing examples in California in which many firms -U.S. and foreign - were enticed to California only to find that the rules of the game (taxes, environmental controls, etc.) changed at some point after the investment had been made. Will Oregon follow the same path? Two groups from Toshiba have visited Oregon within the past 5 months; one from the semiconductor unit and another from the consumer products unit. Firm's primary underwriter is Nomura.
