Governor's Role:

1. Speaker -- Governor is scheduled to speak on Tuesday, August 21 at 10:40 a.m. for 10 minutes. The RNC is asking that the speech be the "Republican Governors' Campaign Report for Reagan-Bush. Governor can bring on stage with him all incumbent Republican governors if he likes. Basically we have the latitude to do "something creative" that delivers a strong message of support and leadership in re-electing Reagan-Bush. I have asked D. Miles and J. Sellers to begin developing some ideas. Whatever we settle on must be cleared by me with Farenkopf. (Note: Luger and Vanderjagt will also be doing something similar.) Governor will be introduced by Permanent Chairman (of the Republican Convention), Bob Michael, and will be speaking as chairman of the Republican Governors' Association.

Note: At 9:26 p.m. Tuesday, Governor Thompson, as chairman of NGA will speak for 5 minutes.

2. Floor Leader -- Governor will serve as a floor leader. Official notice from the Reagan-Bush headquarters will be sent us, probably signed by Bill Timmons. This notification will outline the Governor's specific role.

Security: It is my understanding that Lon Holbrook will be allowed on the floor with the Governor as his security. No weapons allowed. I am asking Lon to clear all details.

Staff: D. Miles will be accompanying Governor. He has not yet been cleared to be on the floor. It is likely, but not confirmed, that the Governor will have 2 extra floor passes which would accommodate Denny's desire to be on the floor. D. Miles should continue to pursue this through the convention headquarters in Dallas, Texas.

Housing: D. Miles has all information on housing of the Oregon delegation. Reservations have been made for Governor, Holbrook and Miles.

A suite has been arranged for the Governor's use at the Hyatt, close to the convention center. Sleeping accommodations in the suite would be available for Holbrook and Governor. No other space is available. It has been assumed by RNC and others that the suite would be only for Governor's convenience during actual convention hours and the Governor would be officially headquartered with the Oregon delegation.

RNC and RGA will also be headquartered at the Hyatt.

Transportation: Discount flight arrangements through the Oregon Republican party have been made. D. Miles has all information and should confirm flights.

Ground transportation has been an on-again off-again proposition. Holbrook should immediately make all ground transportation arrangements.
