
THE PROGRAM

The new Pacific Basin Studies Program offers students the opportunity to study the following subjects related to countries surrounding the Pacific Ocean:

- Languages
 Chinese, Japanese, Spanish, and English for foreign students
- International Business
 Resources, trade, monetary practices, economics
- Political Science and History Government, politics, national development, and international relations
- Cultures of the Pacific Basin Art, philosophy and customs

In addition, seniors will be encouraged to participate in an internship in the Portland area or overseas. The internships provide students with work/study experience in a professional setting related to their career interests.





Students may participate in the Pacific Basin Studies program while majoring in any one of the traditional disciplines offered at Pacific University. The students can therefore earn certificates in Pacific Basin Studies along with their baccalaureate degrees.
